# "Nutella® Sweater Giveaway" OFFICIAL GIVEAWAY RULES AND REGULATIONS ("Official Rules")

If you enter, you are providing your information to Sponsor not to Instagram.

The Giveaway is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old on December 15, 2023 (each, an "Entrant" or "you").
